

2. Please do not quote “**Scheme Rates**”. Scheme rates will not be evaluated.
3. Airline and seats must be confirmed while submitting the quotation
4. The details of the traveler (s) will be provided in the work order.
5. Any bids received by the purchaser after the deadline for submission of bids prescribed by the purchaser, will be declared “**Late**” and will be rejected and returned unopened to the bidder.
6. Sealed quotation marked as “**Quotation for Air Ticket**” should be submitted to the Director, DoAT, Paro Airport on or before 23 September 2019 by 12 Noon and will be open on the same date at 2PM in presence of the bidder or their representative who chose to attend.
7. The rate should be quoted as per the sector given above and will be selected based on the **lowest evaluated bid**.
8. The successful bidder should submit the photocopy of every air ticket along with their invoices for payment.
9. The purchaser reserves every right to reject the bids if it is found not responsive to our terms and conditions and the decision of the tender committee will be final and binding.
