3. Airline and seats must be confirmed while submitting the bids and confirmed itinerary. The validation of fares and availability of seats should be as per the details mentioned above.
4. Quotations without valid documents and sealed envelopes will be **rejected**.
5. Any bids received by the purchaser after the deadline for the submission of bids prescribed by the purchaser, will be declared "Late" and will be rejected and returned unopened to the bidder.
6. Unconditional quotations like an increase of fares during the booking or during the issue of tickets or change of airlines at the time of travel are not entertained.
